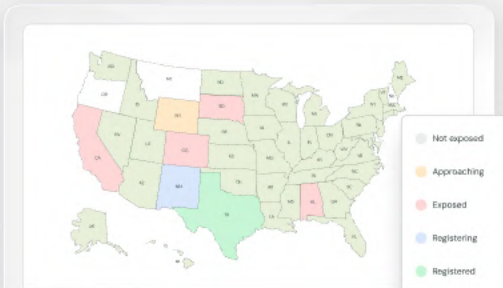
Connect and Monitor

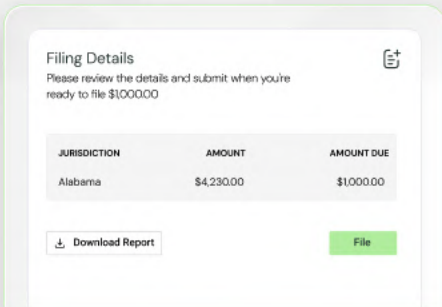
Register and Collect
